Telangana State GST – Reg.


A common web portal of Hyderabad GST Zone, CBEC and Telangana State GST, the first of its kind in the country, with domain name www.telanganagst.gov.in has been launched by the Chief Commissioner of Central Tax & Customs, Hyderabad GST Zone on 01.07.2017. This web portal provides access to the Hyderabad GST Zone website as well as the Telangana State GST website. The Hyderabad GST Zone website can also be directly accessed at www.cgsthyderabadzone.gov.in.

2. The Hyderabad GST Zone website contains updated GST Statutes, Rules, Regulations, Circulars, Trade Notices, Forms, GST Rates, FAQs etc. for the benefit of the trade, industry and service providers.

An important feature of the Hyderabad GST Zone website is a provision for booking of GST outreach training programme by trade, industry and service providers desirous of drawing benefits of sector specific or subject specific programmes. These programmes would be conducted by subject experts from the Department. In addition, the Hyderabad GST Zone provides link for video tutorials on various subjects of interest including Migration, Registrations, Payments and Returns.
