Please refer to the guidelines laid down in the captioned matter by the GST Council Circular No. 01/2017 dated 20th September, 2017 issued from F. No. 166/Cross Empowerment / GSTC / 2017, read with CBEC's F. No. 349/75/2017-GST dated 15th September, 2017.

2. As was reported in our interim reports sent earlier, our officers had been working on it, and the draft lists were handed over to the state authorities quite sometime back. The formal approval of the Government of Telangana to the proposed methodology was communicated vide Memo No. 26258 dated 27.12.2017. Thereafter, the Joint Committee (comprising the Chief Commissioner and a Commissioner from the center, and the Principal Secretary (CT & Ex) and Commissioner SGST from the state) met today (3rd January 2018) and completed the exercise of division of the migrated taxpayers in Hyderabad Zone (which covers the entire state of Telangana).

3. A copy of the **Order No. 01/2018 dated 03rd January, 2018** issued by the Joint Committee (in the format prescribed by the GST Council Secretariat) is enclosed herewith, alongwith the enclosures thereto.

4. The soft copies of the lists of taxpayers so allotted to Center and State are being mailed to the Member (GST) at mahender.singh.irs@gov.in

5. As directed, a mail is also being sent to all the taxpayers allotted to Center, on the lines of the sample forwarded vide Member's D.O.F. no. 349/47/2017-GST dated 20th December 2017.
