**STANDING ORDER No.: 02/2025**

Subject: Wings India 2026 at Begumpet Airport, Hyderabad from 28<sup>th</sup>  
January to 31<sup>st</sup> January 2026 - Reg.

\*\*\*

(1) International Aerospace Exhibition – Wings India 2026, is being held at the Begumpet Airport, Hyderabad from 28<sup>th</sup> January to 31<sup>st</sup> January 2026. The Board vide letter F.No. 520/06/2016 Cus VI (Part II) dated 08.09.2025, granted special permission under section 29(1) of Customs Act 1962 for providing all customs clearance facilitation support from **23rd January to 30th January 2026** at Begumpet Airport, Hyderabad for the Wings India 2026, subject to observance of relevant Rules, Regulations and procedures prescribed under the law.

(2) In this background, following instructions are issued for compliance:

The authorized agent or the Pilot-in-Command of all the Aircrafts that are coming for participation in the Wings India 2026 should file the General Declaration- Inward in duplicate along with the Annexure furnishing the details of parts/ accessories/ tools/consumables that are being brought in the Aircraft. Original copy shall be retained by the Customs and the duplicate copy is required to be handed over to the authorized agent or the Pilot-in-Command. A running serial number should be given to each General Declaration so filed, which shall be treated as Import General Manifest, by the Proper Officer of Customs and details mentioned therein should be entered in a separate register.

(2.1) At the time of departure of the Aircraft, after the completion of the Wings India 2026, the authorized agent or the Pilot-in-Command should file a General Declaration-Outward in duplicate. A running serial number should be given to each General Declaration so filed, which shall be treated as Export General Manifest, by the Proper Officer of Customs, and the details therein should be entered in the aforesaid register. The details contained in the General Declaration-Outward should be verified with the details contained in General Declaration-Inward.

(2.2) All the spares/accessories/tools/consumables (hereinafter referred to as 'Goods') which are brought in, as declared in General Declaration- Inward should ordinarily be re-exported and so indicated in the General Declaration-Outward, filed in this behalf.

However, in the event of non-export of any goods, the same would be assessed to customs duty as applicable. In such an eventuality, necessary Bill of Entry corresponding to the goods shall be filed manually, assessed by the Proper Officer and appropriate customs duty shall be required to be paid. In cases where the goods have been stated as used in the Aircraft for replacement/maintenance, the Proper Officer should corroborate and confirm that the same have been so used for the purpose so stated.

(2.3) The Aviation Turbine Fuel consumed by the aircraft participating in the Wings India 2026 at the Begumpet Airport, Hyderabad, is subject to applicable customs duty, cess etc. which is required to be paid before the departure of aircraft.

(2.4) It will be the responsibility of the Deputy/Assistant Commissioner in charge to ensure that all the records are maintained properly and applicable duty and other dues are collected in time as per provisions of Customs Act 1962.

(2.5) All Officers deputed will be required to strictly follow relevant Rules, Regulations etc., as per provisions of Customs Act 1962.
