**PUBLIC NOTICE NO: 01/2022**

All the Customs Brokers working in the jurisdiction of Hyderabad Customs Commissionerate are hereby informed that the Category 'G' Examination under Regulation 13(5) of the Customs Broker Licensing Regulations, 2018, will be conducted by this Commissionerate, as per details given below:

2. The Category 'G' examination shall include a Written and Oral Examination. The written examination will be for 100 marks and the minimum qualifying marks will be 50 marks. Each applicant may avail a maximum of four chances/attempts to qualify in the Written Examination and oral examination from the date of his/her first appearance for Written Examination. Non-appearance in any Written or Oral Examination after registration will not be counted as a chances/attempt.

**Illustration:** A person who qualifies in the written examination in the first chance/attempt but falls to qualify in the oral exam immediately after the written examination will get another three more chance/attempts for oral examination. If a person qualifies only in the fourth (last) chance/attempt in the written examination, he will get only one chance for oral examination linked to the written examination.

2.1. If a person qualifies in the written examination but does not qualify in the oral examination he/she can use his/her remaining chances to appear directly in the subsequent oral examinations.

3. All Customs Brokers are required to submit applications of their employees who are eligible along with their photo identity and willingness to appear for the Written Examination. The date of examination will be intimated in due course.

**4. ELIGIBILITY FOR CATEGORY 'G' EXAMINATION:**

An Employee/Director/Partner of the Custom Brokers holding a valid 'H' Card under Regulation 13 of CBLR, 2018 (erstwhile Regulation 17 of CBLR, 2013 or Regulation 19 of CHALR 2004) and working in the jurisdiction of Hyderabad Customs Commissionerate and who has passed 10+2 or equivalent Examination shall be eligible to apply for the Category-G Examination. If any applicants claim their qualification as equivalent for 10+2 exam, such applications should be accompanied with a certificate from the respective State Secondary Education Board certifying that such qualification is equivalent to the 10+2 Exam conducted by such State. Applications which are not accompanied with this certificate will be summarily rejected.

5. The list of applicants along with their applications and supporting documents should be submitted by the Customs Broker with their forwarding letter in the following format duly signed by the authorized person:-

## 6. APPLICATION:

6.1. Application should be submitted in the prescribed enclosed proforma, **Annexure-A** and should carry the signature of the candidate as well as the Customs Broker's with seal. Application should be accompanied with the following documents.

1. Photocopies of 10+2 mark sheet (or equivalent qualifications), (original certificates to be shown for verification at the time of submission of application).
2. Photocopy of valid H-card issued from Hyderabad Customs Commissionerates.
3. Photocopy of valid Customs Broker License.
4. TR-6 Challan for Rs.500/- towards examination fee.
5. If there is any Change in name, Gazette Notification/ marriage certificate in support of such change.
6. Proof of residence
7. Copy Aadhar Card
8. Three recent Photographs of the applicant (one affixed on application with self-attention)

6.2. Applications complete in all respects can be submitted by **hand/post in the Custom Broker Section, Customs Commissionerate, Hyderabad** on or before **17.00 hrs of 04.02.2022**. Applications, which are incomplete or not affixed with self-attested photograph or received after stipulated expiry date and time, shall not be entertained. The tentative **Written Exam date** will be on **23.02.2022**.

7. All the Customs Brokers are advised to ensure that the information given in respect of their employees is true. Any mis-declaration will be viewed seriously and suitable action will be taken in accordance with CBLR, 2018. Customs Brokers are also required to ensure that the H-Card held by the candidates are duly renewed well in advance. If the same expires before the date of examination then candidates holding invalid H-Cards will not be allowed to appear for the Exam. In case any candidates leave their job after submitting application for the Exam, the concerned Customs Brokers should forthwith report the matter to this office and surrender the original H-Card by such candidate.

8. Syllabus of the examination shall be as per **Annexure-B** enclosed.

9. The Roll Numbers of the candidates, date, time and venue of the Written Examination will be displayed on the Notice Board of Hyderabad Customs Commissionerate, with a copy marked to the field formations of Hyderabad Customs Commissionerate, after scrutiny of the applications.

10. Candidates and their sponsoring Customs Brokers may note that the decision taken by this office regarding acceptance/rejection of any application will be final and binding upon all the candidates and their Customs Brokers. No communication or

correspondence whatsoever shall be entertained in this regard. They may also note that applications which are incomplete in any aspect or without affixing self- attested photograph or without enclosing requisite documents, self-attested/or received after the stipulated expiry date and time, are liable to be rejected.

11. On passing the Written Examination, **selected candidates will have to appear for Oral Test and the Oral test will be conducted within 2 or 3 days from the date of publication of result of Written Exam.** Candidates who pass both Written as well as Oral part of the Examination will only be considered eligible to apply for G-Card.
