## 2020 New year Greetings to all!!

It is informed that following the launch of un-blocking of e-way bill feature in ACES GST application, the MIS reports on the same are being developed. Meanwhile a Zip file containing the Commissionerate wise list of blocked and un-blocked GSTIN's in CSV/Excel files, is made available under e-Way bill folder updated on a daily basis in Antarang for all the CBIC GST officers to access. The users can access the link under the menu Groups->E-Way bill by following the procedure as given in the Annexure to this letter. Alternatively the users can click on the following link

https://antarang.icegate.gov.in/communities/community/ewaybill.

Each of the CSV/Excel file contains the following fields for each of the blocked GSTIN - Commissionerate, Division, Range, Administered by, GSTIN, Legal Name, Trade Name, Blocked Date, EWB 05 Date, EWB 06 Date, Unblocked Date. The users may make use of filters in the excel/csv to generate various reports pertaining to Blocked GSTIN's such as

- 1. Commissionerate, Division and Range wise list of blocked GSTIN's at Pan India level.
- 2. Centre/State wise segregation of the list
- 3. GSTIN's that are unblocked due to filing of returns
- 4. GSTIN's that are unblocked due to issuance of EWB-06 order.
- 5. GSTIN's that were issued EWB-06 rejection order.
- 6. GSTIN's blocking and unblocking history.

Note: Discrepancy if any noticed in the data, may be informed to this directorate


- Step 1: Click on the linkhttps://antarang.icegate.gov.in/communities/community/ewaybill.
- 2. The system will ask for ICEGATE login credentials
- After successfully entering the credentials the system shall open the screen as given below. Click on the "Follow this community" link at the top right as shown below

5. Now visit the homepage, and search the "Groups->E-Way Bill" menu item as given below to view the daily Zip file containing commissionerate wise blocked/un-blocked GSTIN list.
