The proposed AGT shall be governed by the IZT Policy, ICT Policy and as per the following conditions:

- i. एजीटी 2026 के लिए गणना अवधि के उद्देश्य के लिए कट-ऑफ तिथि 30.04.2026 है।
The cut-off date for the purpose of counting tenure for AGT 2026 is 30.04.2026.
- ii. विशाखापत्तनम क्षेत्र में स्थानांतरित होने वाले अधिकारियों को केवल विशाखापत्तनम क्षेत्र में किसी विशेष आयुक्तालय के लिए आवंटित किया जाएगा। विशाखापत्तनम क्षेत्र के भीतर विशिष्ट पद विशाखापत्तनम क्षेत्र के सक्षम प्राधिकरण द्वारा जारी किए जाएंगे।
Officers due for transfer to Visakhapatnam Zone will be allotted to Visakhapatnam Zone only and not for any particular Commissionerate in Visakhapatnam Zone. Specific postings within the Visakhapatnam Zone will be issued by the competent authority of Visakhapatnam Zone.
