The cutoff date for the purpose of counting tenure for AGT-2025 is **30-04-2026**.

ii) जिन अधिकारियों का स्थानान्तरण वैज्ञाग क्षेत्र में होना बाकी है केवल वैज्ञाग क्षेत्र ही आबंटित होगा और कोई खास आयुक्तालय नहीं। वैज्ञाग क्षेत्र में विनिर्दिष्ट पदस्थापना उस क्षेत्र के सक्षम अधिकारी द्वारा जारी की जाएगी।

Officers who are due for transfer to Visakhapatnam Zone will be allotted to Visakhapatnam Zone only and not for any particular Commissionerate in Visakhapatnam Zone. Specific postings within Visakhapatnam Zone will be issued by the competent authority of that Zone.
