The Competent Authority is pleased to accept the request of Shri K. Venkata Ramana, Inspector to forgo the promotion to the cadre of Superintendent in terms of Para 17.12 of DOP & T, O.M. No 22011/5/86-Estt (D) dated 10-04-1989 in the light of reasons adduced in his representation dated 07-01-2020.

2. Further, he is informed that he will not be considered for promotion to the cadre of Superintendent for a period of 1 (One) year from the date of refusal of promotion (i.e. from 07-01-2020) or till the next vacancy arises, whichever is later.
3. On the eventual promotion to the higher grade, he will lose seniority vis-à-vis his junior promoted to the higher grade earlier irrespective of the fact whether such promotion is ordered by selection or otherwise.
