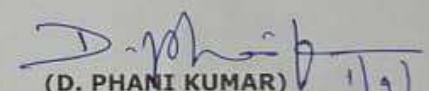
Sub: Work allocation in the cadre of Deputy /Assistant Commissioners, Hyderabad GST Commissionerate- Regarding.
