प्रस्तावना PREAMBLE

सूचना का अधिकार अधिनियम 2005 धारा की 19(1) के अंतर्गत आवेदक, यदि इस आदेश से व्यथित हो तो, अपीलीय प्राधिकारी संयुक्त आयुक्त, केन्द्रीय कर व सीमा शुल्क, हैदराबाद आयुक्तालय ,2वा तल, जी. एस. टी. भवन, हैदराबाद -500 004 के समक्ष इस आदेश की प्राप्ति के 30 दिन के भीतर अपील कर सकता है I Under Section 19(1) of the Right to Information Act, 2005 the applicant, if aggrieved by this order, can prefer an appeal to Sri V.Vasudha Prasada Rao, Additional Commissioner & Appellate Authority of Central Tax & Customs, Hyderabad Commissionerate, 2nd Floor, Room No.321, GST Bhavan, Basheerbagh, Hyderabad-500 004 within 30 days from the date of receipt of this order.

Please refer to the RTI Appeal dt.06.11.2019 filed against the CPIO Order No.157/2019-RTI dated 30.10.2019 and the Order-In-Appeal No.21/2019-RTI dated 20.12.2019 issued by the First Appellate Authority & Additional Commissioner (T).

- In this connection, as directed by the Appellate Authority & Additional Commissioner (T) in the above Appeal Order dt 20.12.2019, the information has been 2. re-ascertained from the Anti-Evasion Section and the same is given as under:
- Point No.1: On the advent of Hyderabad GST Commissionerate, the Anti-Evasion Section received 74 case files where investigation was pending.
- Point No.2: Out of 74 cases, in 37 cases Show Cause Notices are issued, the details of which cannot be provided under section 8(1)(h) in as much as the information sought for relates to quasi-judicial proceedings as held by the Hon'ble CIC in the case of Shri. Vijay Kamble Vs Customs Department, Mumbai reported in F.No.CIC/AT/A/2008/01466 dated 23.03.2009.
- Point No. 3: Out of 74 cases, 67 cases are closed i.e., by way of issuance of SCN-37 cases the details of which cannot be provided as stated in point No.2 above, on payment of tax along with applicable interest and penalty- 21 cases (detailed in the list enclosed in Annexure-B) and by way of transfer to ARC Section/other formations in 9 cases (detailed in the list enclosed in Annexure-C). In remaining 07 cases, the investigations are under process, the details of which cannot be provided in terms of section 8(1)(h) of the RTI Act, 2005.
- Point No.4: The details of officers cannot be provided as it would not serve any public interest as held by the Hon'ble CIC in the case of Shri. Nadeem M.Oomerbhoy
