प्रस्तावना PREAMBLE

Under Section 19(1) of the Right to Information Act, 2005 the applicant, if aggrieved by this order, can prefer an appeal to Sri B.Raghu Kiran, Joint Commissioner & Appellate Authority of Central Tax & Customs, Hyderabad Commissionerate, 2nd Floor, Room No.321, GST Bhavan, Basheerbagh, Hyderabad- 500 004 within 30 days from the date of receipt of this order.
