P R E A M B L E

सूचना का अधिकार अधिनियम, 2005 की धारा 19(1) के तहत, यदि आवेदक इस आदेश से व्यथित है, तो वह सूचना का अधिकार अधिनियम, 2005 के तहत नामित अपीलीय प्राधिकारी डॉ. गांधी डोंथी, अपर आयुक्त, केंद्रीय कर, रंगा रेड्डी जीएसटी आयुक्तालय, जीएसटी भवन, एच.नं.198/7/43, वीआईपी हिल्स, जयहिंद एन्क्लेव, माधापुर, हैदराबाद-500081 को आदेश प्राप्त होने की तारीख से तीस दिनों के भीतर अपील कर सकता है।

Under Section 19(1) of the Right to Information Act, 2005 the applicant, if aggrieved by this order, can prefer an appeal within thirty days from the date of receipt of order to the designated Appellate authority under the Right to Information Act, 2005, i.e., Dr. Gandhi Donthi, Additional Commissioner, Central Tax, Ranga Reddy GST Commissionerate, GST Bhavan, H.No.198/7/43, VIP Hills, Jaihind Enclave, Madhapur, Hyderabad-500081.

Sub: - RTI Act, 2005 – Application filed by Shri. Ramanchandru Tejawath, Flat No K 0601, K Block, My Home Bhooja Raidurg, Hyderabad, Pin:500032 - Reg.

This is in reference to the RTI application filed by Shri. Ramanchandru Tejawath, dated 14/05/2026 wherein the applicant sought certain information.

2. The point wise information sought by the applicant vide the above application in respect of Hqrs. Office, Rangareddy GST Commissionerate is furnished hereunder.

Reply to Point No. 1 to 12: This office has not initiated any investigation regarding the GST liability arising from the transfer of development rights

(TDR) under the Joint Development Agreement (JDA) dated 28.12.2017 entered into between M/s Prahitha Constructions Pvt. Ltd. and the landowners, M/s Jitvan Land Limited and M/s Janina Marine Properties Private Limited. It is informed that the said issue is presently under investigation by the Directorate General of GST Intelligence (DGGI), Hyderabad and hence the information sought is not available with this office.

Further, the information sought by the applicant pertains to third-party taxpayers and consists of confidential information held by the Department in a fiduciary capacity. The disclosure of such information is exempt under the provisions of the Right to Information Act, 2005, inter alia, under the following provisions:

- **Section 8(1)(d)** – Information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party.
- **Section 8(1)(j)** – Personal information relating to a third party, the disclosure of which has no relationship to any public activity or interest and would cause an unwarranted invasion of privacy.

Further, no larger public interest warranting disclosure of the above information has been established. Accordingly, the information sought cannot be furnished under the provisions of the RTI Act, 2005.

ORDER

Accordingly, the application filed by the applicant is disposed of.
