Sub: Discontinuance of Divisional Preventive & Intelligence (P&I) Section in Mahabubnagar, Nalgonda and Khammam Divisions – Reg.

Reference is invited to Trade Notice No. 01/2017-Central Tax dated 21.06.2017 and Trade Notice No. 02/2025-Central Tax dated 24.09.2025 issued by this office, wherein, consequent upon the issuance of Notification No. 02/2017-Central Tax dated 19.06.2017 by the Government of India, the jurisdiction of the Commissionerates, Divisions and Ranges under this Zone was brought to the notice of the trade and taxpayers.

2. It is hereby informed that, pursuant to an administrative reorganization approved by the competent authority, the **Preventive & Intelligence (P&I) Sections functioning in the Mofussil Divisions of Mahabubnagar, Nalgonda and Khammam have been discontinued with immediate effect.**

3. Consequently, all matters relating to Preventive & Intelligence (P&I) Sections hitherto handled by the Preventive & Intelligence (P&I) Sections of the aforesaid Divisions shall henceforth be dealt with by the Anti-Evasion Section of Rangareddy GST Commissionerate.

The trade, industry and taxpayers are requested to take note of the above change and address all communications, representations and submissions relating to the aforesaid matters to the Anti-Evasion Section, Rangareddy GST Commissionerate or such authority as may be specified by the Commissionerate from time to time.
