2. The above officers should join their charges on or before 05.05.2025.

3. Till the new ranges are mapped on 24th and 25th May 2025, the officers will work in existing ranges. For instance, Uppal range is being divided into Uppal-I, II, III & IV ranges. Till the new formations are effectively mapped with system, all the officers posted to Uppal-I, II, III & IV ranges will work in existing Uppal range and they will be mapped accordingly. Same applies to division of Kapra, Nacharam, Ramgopalpet-III etc.

Some ranges are being merged like in Amberpet, 4 ranges are being merged into Nallakunta range. Thus, the officers posted to Nallakunta range will look after the work of 4 erstwhile ranges i.e. Bagh Amberpet, Golnaka, Nallakunta-I & Nallakunta-II. Same applies to new ranges of Ramnagar, Bansilalpet etc.

4. This order will come into effect from 05.05.2025.
