1. The control room duty was in place during the past as a matter of policy as decided by the Head of Office in the Hyderabad GST & Customs Zone, for trade facilitation and to reach out to taxpayers. Secunderabad GST Commissionerate has been assigned the task of functioning of the Control Room and a roster is being implemented on a monthly basis. However, the role of a control room officer is more of a helpdesk to assist the taxpayers visiting the office. This is purely a policy matter and no proper order/instructions/directions have been received from the department on discontinuation of control room duty cum help desk.
