The Merriam-Webster Dictionary defines the term, 'Custodian' as the 'one guards, protects and maintains especially one entrusted with guarding and keeping property and records or with custody or guardianship of prisoners or inmates'. In reply furnished to the RTI application vide order no.22/2021-RTI dated 20.09.2021, the word, 'custodian' has been used in its general understanding that whoever is in charge of files, for the purpose of fixation of responsibility when a file is lost or misplaced and the procedures and action to be taken for such misconduct of officers is governed by CCS Conduct Rules. In view of above, it is to state that this Office is not in possession of any details about the specific information sought at point No.1 of the RTI application.
2. This office is not in possession of any information sought at Point No.2 regarding the rules governing the appointment of custodian of files in the context as discussed at para 3 above.
3. This office is not in possession of any information sought at Point No.3 regarding the appointing authority of custodian of files.
