REVIEW MEETING AT KOLKATA

4th January, 2021

DGTS RELEASES DIGITAL CALENDARS





27th January, 2021





GST Evasions & Seizures

GST EVASION CASE UNCOVERED BY CGST DELHI

18th January, 2021

In the ongoing drive against availing of inadmissible ITC, officers of Central Goods and Services Tax (CGST) Commissionerate, Delhi East unearthed a multi-layered network of fictitious firms being used to generate and pass on fake ITC.

Through the use of extensive data analytics, officers identified and searched 21 premises between 15th to 17th January, 2021, leading to the unraveling of a network of fake firms that were operating since 2017 to pass on fake ITC.

The network of fake firms was being operated by Shri Arvind Kumar, who used to pass fake ITC for a commission of 4 to 4.5% of the invoice amount. Investigation conducted so far has revealed 46 firms to be fictitious which were being controlled by Shri Arvind Kumar and his associates. These firms had no business activity and had been created solely for the purpose of passing on fake ITC. The total fake ITC quantified so far is ₹ 82.23 crore generated out of the fake billing of ₹ 541.13 crore which is expected to increase as the investigation progresses.

Shri Arvind Kumar was arrested under Section 69(1) of the CGST Act, 2017 and produced on 17th January, 2021 before the Duty Magistrate, who remanded him to judicial custody of 14 days till 31st January, 2021. Further investigation in the case is under progress.

It is pertinent to mention here that since the inception of GST Central Tax, Delhi Zone has made 19 arrests in various cases involving GST evasion amounting of more than ₹ 3766.69 crore.

CGST MEERUT UNEARTHED GST EVASION OF ₹ 25 CRORE

15th January, 2021

On the basis of initiative taken by the Chief Commissioner, Meerut Zone, Business Intelligence & Fraud Analytics cell analysed suspected firms. On further investigation CGST Meerut unearthed a case of issuance of fake GST invoices without actual supply of goods and passing on the said fraudulent ITC to the other existing firms after circulation of invoices through a chain of non-existent fake firms. These firms were operated by two brothers Shri Anshul Agarwal & Shri Archit Agarwal based in Moradabad. Prima facie investigation has revealed issuance of GST invoices from these fake firms involving fraudulent ITC of approximately ₹ 25 crore, which may go up further in the ongoing investigation.

During the search conducted at 13 premises of Moradabad, Haryana, Delhi and Punjab, various incriminating records, cash of ₹ 14.99 lakh, accounts maintained in software, cheque books etc. of more than 15 such non-existent firms have been recovered.

The offence committed by the accused due brothers is covered under Section 132(1)(b)&(c) of the CGST Act 2017, falling in the category of cognizable and non-bailable offence under Section 132(5) and the same is punishable under Section 132(1)(i) of the said Act. Accordingly, the above two accused were arrested under Section 69 of the CGST Act, 2017 on 15th January, 2021 and produced before the Economic Offences Court at Meerut. They have been sent to jail on judicial custody for 14 days till 28th January, 2021 by the order of the Special CJM, Meerut.



SEIZURES BY DELHI CUSTOMS (1/4)

In January, Delhi Customs made a significant number of narcotics seizures of 13.42 kg, Gold/Foreign goods worth ₹ 1.46 crore, and 60 kg of Saffron. The seizures are listed as below.

On the basis of suspicion, two Ugandan nationals coming from Entebbe via Doha by flight no. QR578 were intercepted by air customs officers at IGI Airport here on 24th January, 2021. During search of the checked in bags of the two passengers, total 51 pouches containing (approx.) 9.8 kg of white powdery substance, suspected to be narcotics was recovered. When this material was subjected to diagnostic test, prima facie it appears to contain commercial quantity of Heroin, valued at (approx.) ₹ 68 crore.

In view of the above, it is clear that the said passengers had violated provisions of section 8 of the NDPS act, 1985 and had committed offence punishable under section 21, section 23 and section 29 of NDPS act 1985 read along with provisions of the Customs Act, 1962. It is one of the biggest detection of Heroin/narcotics at any international airport in the country. Further investigation in the matter is under process.

Acting on specific intelligence, Delhi (C) Preventive intercepted a parcel at NCT, IGIA on 24th January, 2021. 510 gm Heroin worth ₹ 3.5 crore was found concealed in cavities of skipping ropes. Two separate arrests have been made and sent to 14 days Judicial Custody under NDPS Act. Further investigation is in progress.





SEIZURES BY DELHI CUSTOMS (2/4)

On 15th January, 2021 acting on specific intelligence, officers of Customs (P) Delhi intercepted multiple Consignments of foreign origin smuggled cigarettes of Premium Brands e.g. Gudang Garam, Esse Lights etc. Such interceptions were made at Arrival Shed, Domestic Cargo Terminal, IGIA and at various locations in Gurugram. Total seizure was about 7.27 lakh sticks of foreign origin smuggled cigarettes of Premium Brands amounting to appx. ₹ 1.5 crore. Valuation and further investigation in this matter is under progress.





On 15th January, 2021 Officers of Customs (Preventive) Delhi intercepted two Containers at ICD Garhi Harsaru, ICD PPG. Upon detailed search, four large Diesel generator sets, 9,900 kids camcorder, 2 Network equipment, 8 Led Smart Mirror, 48 Premium Wooden Doors, Printer, Shower head, Ceiling Fan, Carpet, Luxury Bed among other multiple items were found instead of declared very low value Door frames for Oven and Door sets for Ovens. Further investigation is in progress.





SEIZURES BY DELHI CUSTOMS (3/4)

On 15th January, 2021 ACC Export at Foreign Post Office, New Delhi seized 965 gm of MDMA from 1 parcel destined for New Zealand. MDMA was concealed in the cavity of 35 skipping ropes handle.

Delhi Airport Customs intercepted a female Indian passenger who had arrived by flight no. AI1928 from Dubai on 14th January, 2021 and on interrogation the passenger admitted to have left seven Gold bars weighing 816 gm of worth ₹ 36.80 lakh on her seat in the aircraft. The said Gold was recovered and seized. The passenger has been arrested u/s 104 of Customs Act, 1962 and further investigation is in progress.

On 12th January, 2021 Customs officers of ACC Export Commissionerate at FPO New Delhi, seized 6770 tablets of Tramadol 100 mg which were destined for USA. Drugs were declared and packed as diary and gifts.



Delhi Airport Customs intercepted an Indian passenger who had arrived by flight no. SG137 from Dubai on 10th January, 2021 and seized 520 gm Gold valued at ₹ 23.35 lakh concealed in form of paste. The passenger was arrested u/s 104 of Customs Act, 1962.

On 9th January, 2021 Customs officers of ACC Export Commissionerate at FPO New Delhi, seized 1250 gm of Opium & 60 gm of Pseudoephedrine from parcels destined for Australia & USA. The drugs were declared as ayurvedic medicines. A second parcel was seized with 200 gm of MDMA destined for Australia which was ingeniously concealed in the skipping ropes handles & sealed to perfection.



SEIZURES BY DELHI CUSTOMS (4/4)

On 8th January, 2021 Delhi Airport Customs intercepted an Indian passenger who had arrived from Jeddah by flight no. SG9558 and seized 1133 gm Gold jewellery, Apple iPad & iWatch, valued at ₹ 47.21 lakh. The passenger admitted of previous smuggling of 232 gm Gold valued at ₹ 10.48 lakh and was arrested u/s 104 of Customs Act.

On 7th January, 2021 Delhi Airport Customs intercepted an Indian Pax passenger who had arrived from Jeddah and seized 497 gm Gold valued at ₹ 22.46 lakh. On follow-up investigation it led to total three arrests, including the receiver and a second passenger so far u/s 104 of Customs Act.

On 5th January, 2021 Delhi Airport Customs intercepted two Afghan passengers and seized 60 kg Saffron valued at ₹ 15 lakh. The passenger admitted having smuggled Saffron and Commercial items valued at ₹ 45.25 lakh in his earlier visits. Both the passengers have been arrested u/s 104 of Customs Act and further investigation is in progress.



On 3rd January, 2021 Delhi Airport Customs intercepted one Afghan passenger and seized 635.5 gm of white powdery substance prima facie appearing to be heroin valued at ₹ 4.5 crore; which was concealed in abdomen in form of 89 plastic pellets. The passenger has been arrested under NDPS Act.

Delhi Airport Customs intercepted an Indian passenger on 2nd January, 2021 arriving from Dubai by flight no. IX1142 and seized 16 iPhones & one MacBook Air valued at ₹ 17.04 lakh. The passenger admitted of previous smuggling of ₹ 20.05 lakh and has been placed under arrest.



SEIZURES BY THIRUVANANTHAPURAM ZONE (1/6)

In the month of January, 2021 the Customs formations under Thiruvananthapuram Zone, have made a record seizure of 116.50 kg (approx.) of Gold valued around ₹ 53 crore, which led to arrest of 91 persons, with the excellent and dedicated efforts & detection of the officers of this Zone. The seized Gold was found concealed in the shape of seeds inside dates and chocolates, cylinders inside door closures, as plates in the emergency lamp, as Gold thin sheets inside laptops, metal strap of trolly bag of passengers, as Gold sheets of coffee/tea mugs, screws of a trolley bag, inside the motor of mixer grinder, thin Gold plates inside a toy car, in person of the passengers in rectum in the form of capsules, body concealment, etc. This Zone has also made a seizure of 400 gm of Silver Granules, Foreign Currency worth ₹ 32 lakh and 16 Mavic Air-2 Drones. In addition to this, Foreign Currency of different nations equivalent to ₹ 1.28 crore and Indian Currency ₹ 44.56 lakh, was detained and further investigation is in progress. The seizures are listed as below.

Seizure of 2.6 kg Gold concealed as cylinders inside Door closers, from two passengers who arrived from Jeddah in Indigo flight 6E 8906, at Calicut Airport on 1st January, 2021.





Seizure of Gold compound weighing 90 gm approx., concealed inside dates and chocolates in the shape of seeds, on 2nd January, 2021 from a passenger who arrived from Dubai in Indigo flight 6E89, by Calicut AIU Batch C.



SEIZURES BY THIRUVANANTHAPURAM ZONE (2/6)

CPD Calicut has made a seizure of 400 gm of Silver granules from a passenger who arrived from Sharjah in Air Arabia flight G9454 on 5th January, 2021. The same were extracted from 725 gm of paste like material found in 4 capsule shaped packets concealed inside the rectum of the passenger.







Seizure of 1134 gm of 24k Gold worth approx. 59 lakh at Calicut Airport on 6th January, 2021 from 4 passengers who arrived from Sharjah in Air Arabia flight G9454. The Gold was concealed as coins inside check-in baggage of the passengers.

Seizure of 129 gm of 24K Gold (3 small plates) on 7th January, 2021 by AIU Batch A at Calicut Airport from a passenger who arrived from Dubai in flight IX1346. Gold plates were concealed inside the battery of a LED emergency light.





Seizure of 24k purity Gold in the form of thin sheets concealed in a Laptop from two passengers who arrived from Dubai in Spice Jet flight SG141, by Calicut AIU officers on 7th January, 2021.



SEIZURES BY THIRUVANANTHAPURAM ZONE (3/6)

Excellent detection and seizure of three Gold sheets weighing 65 gm concealed in mugs, by officers of ACC, Cochin on 8th January, 2021.





Seizure of 1798 gm of Gold from two passengers who arrived from Dubai flight IX1744, by AIU Kannur, on 11th January, 2021. The Gold was concealed as Gold chains and Gold wires inside the metal straps of their bags.

Detection of outright smuggling of Gold in the form of compound concealed in 4 capsules in rectum from a passenger who arrived on 12th January, 2021. The said compound in concealed form weighed 1069 gm and on extraction recovered 973 gm of Gold valued at ₹ 4914,623/- (MV).



Based on scrutiny of data obtained from APIS, on 19th January, 2021 officers of Trivandrum AIU B batch, identified a suspect passenger and in a meticulously planned operation shadowed the passenger from aerobridge resulting in the recovery and seizure of 1.810 kg of Gold blocks from the hand baggage.



SEIZURES BY THIRUVANANTHAPURAM ZONE (4/6)

Officers of UB, Karipur effected a seizure of approx. 1 kg of Gold from a passenger who arrived from Dubai. The Gold was detected during X-ray screening which was concealed as biscuit cut into half and kept inside Nutella chocolate bottles.

Seizure of Currency

Seizure of Foreign Currency totally worth ₹ 17.30 lakh by CPD Trivandrum, from three passengers at departure hall of Thiruvananthapuram Airport on 16th January, 2021.



Detention of unaccounted Foreign Currency of different Nations equivalent to ₹ 1.28 crore and Indian currency ₹ 44.56 lakh, on 22nd January, 2021 by CPD, Thrissur, from M/s. Forex Duty Paid Shop, Guruvayur and from the residence of its Owner. Further investigation is in progress, which may lead to the seizure of the detained Currency.







SEIZURES BY TRICHY CUSTOMS (P) ZONE January, 2021

On 28th January, 2021 the Officers of Trichy Customs (Preventive) Zone seized 1634.50 gm Gold, totally valued at ₹ 81.82 lakh at Trichy International Airport. Two persons has been arrested.





Officers of Trichy Customs (Preventive) Zone seized 567.50 gm Gold, valued at ₹ 28.64 lakh, which was concealed in the form of paste in a carton pack containing liquor worth ₹ 5,500/-, at Trichy International Airport on 13th January, 2021.



On 10th January, 2021 the Officers of Trichy Customs (Preventive) Zone recovered 399 gm Gold, totally valued at ₹ 20.29 lakh, which was kept inside the flush tank in gents toilet at immigration area, Trichy International Airport.





SEIZURES BY KOLKATA CUSTOMS

January, 2021

Kolkata Customs intercepted a significant seizure of 1.4 kg of Gold concealed in the form of hollow cylindrical shaped piece, worth ₹ 70.55 lakh. The seizure was effected by Batch-C of AIU at NSCBI Airport on 24th January, 2021 after a lot of intensive interrogation & strenuous efforts.



Officers of Preventive Commissionerate, Kolkata Customs Zone intercepted one person at Khidderpore on 16th January, 2021 recovering 26 pieces of foreign origin Gold biscuits, weighing 3.02978 kg and valued at ₹ 1.52 crore.

Acting on specific intelligence, on 12th January, 2021 Officers of Preventive Commissionerate, Kolkata Customs Zone intercepted one passenger carrying 7 pieces of Gold biscuits of foreign origin weighing 816.13 gm valued at ₹ 41.54 lakh from a Sealdah bound train coming from Bangaon.

On 8th January, 2021 Officers of Preventive Commissionerate, Kolkata Customs Zone effected seizure of 15 pieces of Gold rods weighing 2.295 kg valued at ₹ 1.16 crore and Currency ₹ 11.10 lakh from a premises at Burtolla Road, Kolkata. Two persons have been arrested.



SEIZURES BY MUMBAI CUSTOMS-III

January, 2021

Mumbai Customs on 10th January, 2021 while rummaging of the Air India flight no. AI1946 which arrived from Dubai via Kannur at CSMI airport, resulted in recovery of 14 Gold bars of 10 Tola each from the hollow pipe under the seat, weighing 1.633 kg, valued at ₹ 73.35 lakh.





On 27th January, 2021 Mumbai Customs rummaging of the spice jet flight no. SG174 which arrived from Dubai at CSMI airport resulted in recovery of 2 Gold bars of 1 kg each beneath the tissue paper compartment in toilet, totally weighing 2 kg valued at ₹87.58 lakh.

GOLD SEIZED BY CUSTOMS GOA 23rd January, 2020



Officers of Goa Customs seized 2170 gm of foreign origin Gold bars having approx. value of ₹ 92.77 lakh from a domestic passenger at Dabolim Airport who was on a flight from DEL-GOI sector on 23rd January, 2021.





SEIZURES BY CHENNAI CUSTOMS

January, 2021

On 7th January, 2021 Chennai Airport Customs seized and recovered 546 gm of Gold valued at ₹ 28.7 lakh under Customs Act concealed as chocolate. On opening the wrapper, a plastic packet containing Gold paste was recovered.



On 2nd January, 2021 Chennai Air Customs seized 937 gm of Gold valued at ₹ 48.27 lakh under Custom Act from 2 passengers who arrived from Dubai by flight no. AIIX 1644. The Gold paste was concealed in rectum, and Gold plates & cut bit were recovered from handbag.






AMRITSAR CUSTOMS SEIZED 905 GM GOLD 5th January, 2020

Success Story

DRI SEIZES 55.61 KG OF FOREIGN GOLD WORTH ₹ 28 CRORE

21st January, 2021

In a spectacular bust of the Myanmar-India Gold smuggling network, the Delhi Zonal Unit of the Directorate of Revenue Intelligence (DRI) seized 55.61 kg of foreign origin Gold valued at ₹ 28 crore from eight persons at two locations, i.e. Delhi and Lucknow on 21st January, 2021.

Specific information was developed by DRI regarding smuggling of huge quantity of origin foreign Gold Myanmar into India through the Indo-Myanmar border sending it to different parts of India. The spurt of economic activity seen after the lifting of COVID-19 related lockdowns throughout the country, pent-up combined with the demand for Gold, coincided with a surge in such smuggling activities. The blocking of air routes through the lock down period also saw a significant shift in the modus operandi of smugglers from the air routes to the land route through the



Indo-Myanmar border.

Due to the intensive countersmuggling efforts by DRI, the smugglers have been seen to shift their preferred modus from vehicle concealment to concealment. in-person in However, the latest operation, codenamed "Golden Triangle", which was coordinated effort by officers of Delhi Zonal Unit and Lucknow Zonal Unit of DRI, the modus of human concealment has also busted where the carriers were found to have been concealing the Gold bars in belts worn around their waists.

passengers were Five such intercepted by officers of DRI, Delhi Zonal Unit near Delhi and three \ passengers were intercepted by the officers of DRI, Lucknow Zonal Unit at Lucknow. Search of the persons resulted in recovery and seizure of 335 Gold bars, weighing 55.61 kg. The said 8 persons have been apprehended and further investigations are underway.



The Hon'ble Union Minister of State for Finance & Corporate Affairs Shri Anurag Singh Thakur visited the office of DRI, Delhi Zonal Unit to congratulate the officers of DRI for the successful seizure. CBIC Chairman Shri M. Ajit Kumar



and Pr. DG, DRI were also present.

Shri Thakur appreciated the efforts made by the officers and encouraged them to effect even bigger seizures in the future. He also motivated the "I will officials stating, personally visit those units where CBIC Officers have outperformed and set new benchmarks in tackling smuggling activities. Their valuable insights must be exchanged within the system for the benefit of all".
